

PRESENTATION :

Article 1 : The establishment reserves the right to refuse access to customers whose dress is not appropriate, to customers with noisy or incorrect behavior, to customers who are alcoholic or whose behavior is contrary to morality and public order.

Article 2 : Unaccompanied customers must be at least 18 years of age and present a valid identity document (national identity card, passport or residence permit). In the event that you cannot provide us with this document, we will be forced not to accede to your room rental request.

Article 3 : The duration of the stay is limited to a **maximum of 7 nights** (subject to availability).

Article 4 : Access to our establishment is strictly reserved for residents. All animals are prohibited in our establishment.

PAYMENT :

Article 5 : The tourist tax is € 0.50 per person per night.

Article 6 : Full payment for the stay is made on arrival, in Euros. **Bank checks are not accepted.** The bank cards accepted are: Visa, Mastercard, AmericanExpress.

Article 7 : Failure to pay will result in the immediate expulsion of the client as well as legal proceedings for the settlement of sums incurred and remaining due.

Article 8 : A **deposit of 10 euros** will be retained upon your arrival. If you lose the access card to your room and / or the towel, this amount will be kept or charged to the credit card provided.

ACCESS TO ROOMS :

Article 9 : On the day of arrival, access to the room is possible from 3 p.m. Our luggage storage is available, under your responsibility: do not leave any valuables there. In the event of a change of room during the stay, luggage must be left before 11 am in the luggage room; access to the new room is possible from 3 p.m.

Article 10 : The rooms must be vacated before 11 a.m. on the day of departure and the access card must be returned under penalty of penalty (see Article 8). You can request a late departure up to 1 p.m. at a cost of 10 euros. Payment for this must be made before 11 a.m. on the day of departure at reception, subject to availability.

Article 11 : Breakfast is served between 7:30 am and 10 am.

Article 12 : The reception is closed between 11 p.m. and 7 a.m. (inform the receptionist if you wish to arrive after 11 p.m.).

NUISANCES :

Article 13 : For the respect of the rest of the other customers, take care not to make noise especially between 22h and 8h of the morning. The hotelier can invite the client to leave the establishment, as soon as the noise generated is likely to affect the tranquility of the clientele (art.R.1334-30 and R1334-31 of the Public Health Code) . All trade is strictly prohibited.

Article 14 : Alcoholic beverages are prohibited in the accommodation section.

Article 15 : In your absence, do not leave in your room and in the luggage room any money, identity papers or valuables (jewelry, camera, camera, ipod, ipad, etc.)

Article 16 : It is strictly forbidden to smoke in the hostel, if we find a violation of this rule a **fine of 100 euros will be immediately applied** (including electronic cigarettes). It is also strictly forbidden to dismantle fire detection devices.

Article 17 : It is forbidden to put objects on windows as well as in corridors and common areas. In the dormitories, everyone must keep the personal spaces (beds and locker) and the collective spaces (shower, WC, corridors) in order and in good clean condition.

THE INTERNAL RULES of the Hostel apply to all customers. Any reservation and stay tacitly implies the acceptance of the particular conditions and the rules of procedure of the Inn. In the event of non-compliance by the client with one of these provisions, the hotelier is obliged to invite the client to leave the establishment, without any compensation.

NB: Our establishment is placed under 24-hour video surveillance.
